## Call for Papers

## Youth & City: Experience based Potentials and Inequalities

for the section session of the ÖGS section *Youth Sociology* at the Sociology Congress 2023 "Critical Times".

Crises (COVID-19 pandemic, war in Ukraine as well as the resulting global shortages) now shape the everyday lives of many people regardless of age group. Against the backdrop of growing poverty, rising unemployment, and increasing social polarization in Europe, basic concerns about the conditions for a more socially fair, climate-friendly life come to the fore. How do the effects of "post-political" conditions<sup>1</sup> interact with the individual process of growing up of a young person? With this call, we are primarily interested in the subjective perspective of the young individual and corresponding forms that attempt to capture currently given complex socialization processes.

Unfortunately, crises often reinforce already existing social tendencies towards social exclusion and disadvantage. As aspects such as poverty, exclusion, and social pressure to conform and to perform become increasingly prominent, the everyday urban lives of young people end up being shaped by varying conflicting conditions.<sup>2</sup> Radicalized behaviors of teenagers in public spaces, such as those recently observed on New Year's Eve 2022/23 in Berlin, pose further questions: Should radicalized behavior by young people be understood primarily as an expression of powerlessness? To what extent does urban space appear suitable for young people to deal with current core problems outside institutionalized spaces such as school or family? To what extent does urban space offer opportunities to experience difficult emotions without having to harm others?<sup>3</sup>

At the same time, circumstances of crisis hold the opportunity to integrate change and conflict into one's personal life and to pursue individual paths to possible solutions. In view of the

increasingly different social living conditions of young people, it appears to be crucial to also question guiding concepts for promoting the development and participation of young people: in comparison to one decade ago, "participation", "self-determination" and "development of individual resources" seem to have lost much of its original potential.

The section of *Youth Sociology* of ÖGS aims to expand methodological youth research by also focusing on approaches of experience-based research<sup>4</sup>. The panel will present and discuss research approaches to questions of self-perception and self-organization of young people in current crisis situations: unspecified leisure time, self-experimentation, sensual-physical experience, creative expression or interaction. The common goal is to explore expanded "action space-oriented potentials" of young people in extra-institutional, public spaces of the city. Related research approaches as well as theoretical contributions beyond those mentioned above are equally considered.
